### **COMMITTEE – UNITED NATIONS COMMISSION ON STATUS OF WOMEN**

#### **AGENDA: “Gender Equity: Key to Global Development and Enrichment”**

Gender equality is not only a fundamental human right, but a necessary foundation for a peaceful, prosperous and sustainable world. The Commission on the Status of Women (CSW) is the principal global inter-governmental body, and was established by a functional commission of the Economic and Social Council (ECOSOC) by resolution 11(II) of 21st June 1946. The CSW is exclusively dedicated to the promotion of gender equality and the empowerment of women. It is instrumental in promoting women’s rights, documenting the reality of women’s lives throughout the world, and shaping global standards on gender equality and the empowerment of women. It has formed a new multi-year programme of work for the years 2021-2024, and the same is contained in ECOSOC resolution 2020/15. The priority and review themes for 2022 have been laid down as ‘Achieving Gender Equality and the Empowerment of all Women and Girls in the Context of Climate Change, Environmental and Disaster Risk Reduction Policies and Programmes’, and ‘Women’s Economic Empowerment in the Changing World of Work’ respectively.

The Institute through the MUN’s Committee has taken a resolve to ponder and deliberate on the theme, and lay down a situation of global development and enrichment.

## **COMMITTEE – UNITED NATIONS SECURITY COUNCIL**

### **AGENDA: “Cyber Terrorism: Undermining International Security”**

The threat posed by cyber terrorism has grabbed global attention. Journalists, politicians, and experts in a variety of fields have popularized a scenario in which sophisticated cyber terrorists electronically break into computers that control dams or air traffic control systems, wreaking havoc and endangering not only millions of lives but national security itself. Most critical infrastructure is networked through computers. Hackers have demonstrated that individuals can gain access to sensitive information and to the operation of crucial services. Terrorists could thus follow the hackers’ lead and then, having broken into government and private computer systems, cripple or at least disable the military, financial, and service sectors of the nations.

The Committee laid forth seeks to examine the reality of the cyber terrorism threat, present and future, and also strive to resolve the situation with amicable deliberation.

## **COMMITTEE – UNITED NATIONS GENERAL ASSEMBLY**

### **AGENDA: “Drug Trafficking: Hampering International Peace and Security”**

The illicit drug trade remains one of the most dynamic criminal markets. With ample evidence showing the involvement of criminal organizations in all stages of the illicit drug trade, the issue remains a global concern, with different regions affected by emerging and escalating drug trafficking phenomena. In the Declaration on the Rule of Law, Member States of United Nations (UN) have time and again acknowledged the importance of strengthened international cooperation in countering the global drug problematic situation. The General Assembly (GA) has also recognized that “despite continuing increased efforts by States, relevant organizations, civil society and non- governmental organizations, the world drug problematic situation undermines socio- economic and political stability and sustainable development”.

The Institute via the present Committee attempts to create a dent in the existing approach, and shall also seek to resolve the pertinent issues.
