# **ABOUT SHAHDARA DISTRICT LEGAL SERVICES AUTHORITY**

District Legal Services Authorities (DLSAs) play a crucial role in ensuring access to justice at the grassroots level in India. Established under the Legal Services Authorities Act, 1987, DLSAs operate at the district level and are integral to the legal aid system in the country. Their primary mandate is to provide legal aid and services to those who cannot afford legal representation, thereby upholding the principles of justice and equality.

Shahdara District Legal Services Authority functions under the aegis of National Legal Services Authority (NALSA) and the Delhi State Legal Services Authority (DSLSA). Following are the primary functions performed by Shahdara District Legal Services Authority:

- 1. Providing Free Legal Services to eligible beneficiaries as per Section 12 of the Legal Services Authority Act: DLSAs provide free legal services to eligible individuals, including legal representation, advice and assistance for drafting. This is especially critical for marginalized sections of the society, including the poor, women, children, transgenders and the elderly. Provision for legal services also includes providing legal counselling in all matters and primarily in matrimonial disputes, POCSO cases and crimes against women.
- 2. Legal Literacy and Legal Awareness: DLSAs conduct legal literacy programs to educate the public about their legal rights and the legal system. These initiatives help demystify legal processes and empower individuals with knowledge about their entitlements. Organization of workshops, seminars, and training sessions raises awareness about legal issues and available legal aid services.
- 3. Pre-Institution Mediation and Settlement: In terms of the provisions of Commercial Courts Act, 2015, it is mandatory for the parties to first approach DLSA for PIMS and only thereafter can they file a case before Hon'ble Court.
- 4. Victim Compensation: DLSA awards and disburses compensation to victims of various offences as per provisions of Part-I and Part-II of the Delhi Victims Compensation Scheme, 2018.
- 5. Organisation of Lok Adalats: Lok Adalats are one of the various Alternative Dispute Resolution (ADR) mechanisms, whereby matters are settled between the parties. This helps in putting an end to the matter.

The work of DLSAs is pivotal in bridging the gap between the legal system and the marginalized sections of society. By providing essential legal services, promoting legal literacy, and facilitating alternative dispute resolution, Shahdara District Legal Services Authority aims to ensure access to justice for all.

# **ABOUT CERTIFICATE COURSE**
