## 7.3 - INSTITUTIONAL DISTINCTIVENESS

Ideal Institute of Management and Technology was established in the year 1999 under the auspices of New Millennium Education Society. The Institute is affiliated to Guru Gobind Singh Indraprastha University, Delhi, since 28th February, 2000. Being a NAAC accredited Institution and awarded with 'A' grade by Guru Gobind Singh Indraprastha University, Government of National Capital Territory and State Free Regulatory Committee, Delhi it melds state of the art infrastructure with quality in education as its paramount principle. Activities held at the Institute are a reflection of the resolve towards perfection instilled by the founding father Late Shri Rakesh Aggarwal whose vision was to develop the Institute into a centre for excellence in Professional Education. In pursuit of its mission to grow as an abode of all round excellence, the Institute also disseminates a wide and varied array of publications ranging from journals to newsletters and magazines of repute.

From its advent, the Institution has acquired a credible position in the fields of Law, Business Administration, and Computer-Aided Management programmes. The students of the Institute deliver best results as they consistently become top the university examination both in the subjects of Law as well as Management. It has been nurturing pioneers and forerunners in these fields who have continually attained highly reputable careers as judicial officers, civil servants, advocates, academicians, managers, and professionals in the industry.

The Management Committee recognizes the efforts of the star students by awarding them annually for their "above and beyond" special contribution to the Institute. The institute yearly awards the First and the Second Rank Achievers with a Scholarship of Rs. 11,000 and Rs. 7,500 respectively. The Committee also recognizes the outstanding athletes annually. These are chosen amongst the students who exhibit exemplary leadership on and off the field combining athletic and humanitarian achievements.

In addition to the above-stated awards, various Central as well as Delhi Government, and Guru Gobind Singh Indraprastha University Scholarship Schemes are also made available for the students.

The National Scholarships are available both to Minorities (Post-Matriculation Scholarship Scheme) and Meritorious Students (Merit-cum-Means Scholarship for Professional and Technical Courses) provided the family income does not exceed Rs. 2 lacs per anum.

The Delhi Government Schemes reimburses 100% tuition Fee and the same is available for the students who score an aggregate percentage of 60% (a further relaxation of 5% for SC/ ST Category Students). The Schemes are given to beneficiaries under National Food Security Scheme, to those not covered under the first category and whose family income is up to Rs. 2.5 lacs per anum and is also extended to the ones whose family income certificate is above Rs. 2.5 lacs but not exceeding Rs. 6 lacs per anum.

Guru Gobind Singh Indraprastha University offers Scholarship Scheme for Economically Weaker Sections.

E-District Portal for Reserved Category and Minorities is also available to Post-Matriculation Scholarship (OBC), Post-Matriculation Scholarship (SC) and Merit Scholarship (SC/ ST/ OBC/ Minorities).

The students domiciled in Bihar can also avail scholarship under the State Government Scheme.
