Report of Election Proceedings for Election/Nomination of Student Representative to the Grievance Redressal Committee of the Institute Date of Election: Saturday, 16th September 2023 (Timings - 2.00 pm - 4.00pm)

In view of the directions issued in Writ Petition No. 793/17 before the Hon'ble High Court of Delhi in the matter of suicide committed by Sushant Rohilla, student of Amity Law School, GGSIP University, the institute conducted the election for the student member in the Student Greivance Redressal Committee in the auditorium of the institute on Saturday, 16th September 2023 from 2.00 PM to 4.00 PM.

The election proceedings were presided over by Prof. (Dr.) Anil Parkash Sharma, Director of the Institute. Prof. (Dr.) Arun Gupta, Principal (School of Law) was the Observer in the election proceedings. The meeting was attended by Dr. Vineeta Sharma, Principal BBA (1st Shift), Dr. Seema Nath Jain, Principal BBA (2nd Shift), Dr. Satpal Arora, Dr. Jasdeep Singh, Ms. Shailja Khosla (Members of Student Grievance Redressal Committee) and all class in-charges, faculty members and all students' representatives elected in first stage.

The modus adopted for nomination of student representative to the Grievance Redressal Committee was in two stages.

In first stage 16 student representatives were elected from different departments i.e. Law, BBA (1st Shift) and BBA (2nd Shift). The election proceedings at this stage were conducted on Thursday, 14th September 2023 by the respective class in-charges in their classes and forwarded the names of interested students.

In second stage, an Election Meeting was called at 2.00PM on Saturday, 16th September 2023 for election of the student representative to the Grievance Redressal Committee of the institute presided over by Prof. (Dr.) Anil Parkash Sharma, Director of the Institute and Prof. (Dr.) Arun Gupta, Principal (School of Law) as Observer.

In this process all the elected students of first stage (candidates) were asked to give their views on the following point upon which all of them were required to caste their vote in favour of other candidates.

"what do you understand by grievance & how will you justify your nomination for the Grievance Redressal Committee for GGSIP University?"

After expressing their views all the candidates were asked to vote for one candidate and after voting the four highest scorers were nominated as the candidates for final voting to elect the Student Representative to the Grievance Redressal Committee.

Final voting was done for four candidates namely Ms. Khushi Thawal, Mr. Deepanshu Kaushik, Mr. Saksham Gupta, Ms. Somya Gupta, the top scoring candidates in previous voting.

All the candidates were asked to cast their vote in favour of any one of these candidates to elect the final Student Representative to the Grievance Redressal Committee. The final tally/results were as under:
